

Armband/Wristband Procedures

To receive a wristband:

The required Waiver form is in the *premium list* and the *judging program*. Please complete the form before beginning this process. It will save a lot of time.

The Waiver requires you to print your name, sign, date, and list your phone number and email address. Bring the completed form to the Roberts Center Convention Hall main lobby. Your temperature will be recorded and you will receive a wristband.

You must wear the wristband inside the show room. Wristbands are required for all exhibitors, handlers, helpers, visitors, workers, and vendors. If you do not have an armband on you will be asked to leave the show room until you complete the required waiver and receive your wristband.

The wristband issued by the Regional committee will be valid through Friday. Wristbands and armbands for the all breed shows will be available Thursday and Friday.

To receive armbands:

After receiving a wristband you may proceed to the armband table. Please have the armband numbers for your dogs available when you approach the armband table to expedite this process. Catalogs will not be available until Monday morning at 7:30 AM so you must know the numbers you are needing. Ring stewards will not have shareable catalogs.

Wristband and Armband Pickup times

You will be able to pickup wristbands and armbands as follows:

Sunday October 11th – 3 PM to 6 PM

Monday October 12th – 7 AM to 10 AM

After 10 AM Monday armbands will be available for pickup at a table inside the show room.

Stewards and judges will be aware to look for correct armbands and wristbands.

SOCIAL DISTANCING

I will, to the best of my ability, practice proper social distancing as recommend by the State of Ohio "Stay Safe" directives, as well as practice good hygiene (hand washing, use of hand sanitizer, wearing of a mask when required, etc.) and follow other health recommendations. I will not sit in groups closer than 6 feet and will practice social distancing at all times.

HEALTH REPORTING

- I have not experienced new or worsening symptoms of possible COVID-19 in the last 14 days, including cough, shortness of breath or difficulty breathing, chills, repeated shaking with chills, muscle pain, headache, sore throat, loss of taste or smell, diarrhea, feeling feverish or a temperature greater than 100°. I have not had close contact with a person symptomatic or confirmed to have COVID-19 in the last 14 days.
- I have not been diagnosed with COVID-19 within the last 14 days. If I have been infected by COVID-19 at any time, I have been medically released to return to normal activities.
- If I develop a fever and symptoms, such as a cough or difficulty breathing, or if I am diagnosed with COVID-19 within 14 days of this event, I will report this information to 2020 American Boxer Club Regional Cluster.
- Should symptoms develop during the event, I will report symptoms to 2020 American Boxer Club Regional Cluster /Show Management and immediately leave the event.
